

Working together to address complex problems using the Strategic Prevention Framework (SPF)



Prevention & the Continuum of Care

Prevention strategies utilize a public health approach to address problems universally or within a community. Selective prevention measures target subsets of the total population that are considered at risk for substance abuse by virtue of their membership in a particular segment of the population. Indicated prevention aims to identify individuals who are exhibiting early signs of substance abuse and other problem behaviors; and to involve them in special programs.





Prevention at a Glance

- \$781K spent on prevention activities; 13 providers in network
- 50K individuals in our community touched by prevention programs
- Milwaukee County Substance Abuse Prevention Coalition
 - Drop Boxes in Police Stations / Drug Mail Back Partnership
 - Drug Take Back Initiatives / Light & Unite Red (NDAFW)
- Involvement in and leadership with numerous other coalitions in Milwaukee County pertaining to Suicide Prevention and AODA Prevention
- Distributed 5000 gun locks





Evidence Based Prevention Programs

Class Action- AODA Prevention programming for youth 13-18.

Thinking Under the Influence - Prevent and reduce underage alcohol abuse and binge drinking among LGBT youth & young adults 14-24 years.

Botvin's LifeSkills Training - Life skills curriculum to youth in elementary and middle school grades.

All Stars Program - Reduces the demand for AODA for 30 high risk Hispanic families.





AODA Treatment and Recovery Services



CARS AODA Residential Services

- Rebecca receives comprehensive screen from an Access Point (community based or CARS) to determine recommended level of care
 - CARS, IMPACT, Justice Point, M&S Clinical Services, UCC, and WCS
- AODA residential is recommended and accepted by Rebecca

residential:

- 75.11 AODA Medically Monitored residential (people who present with high medical needs, such as history of hyper tension, diabetes, etc.)
- 75.14 Transitional AODA residential



CARS AODA Residential Waitlist

- Rebecca selects provider from AODA residential provider directory
 - Meta House (F and children), 2nd Century (F), UCC (F, M and children), Matt Talbot (M), Jeannetta Robinson House (F, M co-located)
- Access Point waitlists Rebecca according to priority designation, if any
- Federally designated priority populations:
 - >IV Pregnant Women
 - ➤ Pregnant Women
 - >IV Drug Users (IV use is defined as IV use in the last 12 months)
 - *New due to State Targeted Response (STR) funds, any person with an Opiate Use Disorder (OUD)



CARS AODA Residential Interim Services

- Priority populations must receive interim services within 48 hours of intake, this includes:
 - Information/referral for HIV, TB, Hep C, PNCC, etc.
 - Assignment of a Recovery Support Coordinator (RSC)
 - Offered an alternate level of care
 - Day Treatment
 - Outpatient
 - And recovery support services such as Peer Support
- All people waitlisted for AODA residential are offered an alternate level of care



CARS AODA Waitlist Management

- CARS manages the waitlist daily, dedicated staff provide oversight with people and providers
- Providers submit daily census logs to CARS in order to manage the day to day of residential activity
- CARS sends a weekly spreadsheet to the State on priority populations waitlisted for AODA residential services
- Providers attempt contact with people placed on their waitlist to ensure clinical updates are received and contact information is current
- People are kept on the waitlist for 120 days
