# **EMERGENCY SHELTERS**

### **COORDINATED ENTRY SHELTERS:**

Currently, listed shelters in this section are utilizing the 2-1-1 Coordinated Entry System. This means that all referrals for these shelters must come via a 2-1-1 referral. It's important to note the shelters are primarily filled via the Coordinated Entry system, Monday-Friday 9:00am-5:00pm. While you can contact 2-1-1 during the off hours, please keep in mind shelter space is typically full at those times. Arrival without contacting 211 at these locations will not facilitate the person's entry into shelter.

Coordinated Entry is available 24/7 by dialing 2-1-1 / local 414-773-0211 / toll-free 1-866-211-3380. Police officers may initiate the call for the person with consent. Persons may also text their ZIP Code to 898-211 to engage with a Community Resource Specialist via text on weekdays from 9am to 9pm. You can also go to a Coordinate Entry Mobile site at Repairers of the Breach, 1335 W Vilet St on Monday mornings, or St. Ben's, 1015 N 9<sup>th</sup> St on Wednesday afternoons. You can also email coordinatedentry@impactinc.org for a referral for someone to contact you. The assessment takes about 10 minutes to complete.

# CRISIS/MENTAL/MEDICAL HEALTH LEGAL INFORMATION

#### Information on how people enter Mental Health hospitals:

Under Wisconsin law (Chapter 51), a person may enter a psychiatric hospital in several ways. Most people agree to it voluntarily after seeing a psychiatrist at the hospital. Persons with health insurance or Title 19 may be able to get services at certain hospitals in the Milwaukee area which have psychiatric departments. You may call the hospital or your health insurer to learn if the situation will be covered. Persons without insurance coverage can be seen at the Milwaukee County Behavioral Health Division, Psychiatric Crisis Services (PCS) at 9455 W Watertown Plank Road. The 24-hour telephone number at PCS is 414-257-7260. Outpatient treatment options may also be available through the person's doctor, psychiatric facilities or other medical centers.

While it is better to have a person agree to go to the hospital, there are certain times when the police should be called, such as if the person appears to be mentally ill, dangerous, and refuses to go to the hospital.

# **Dementia and Mental Health Crisis Response in Wisconsin**

When someone is in a crisis situation and is unable to care for themselves or is in danger of hurting themselves or others (as in the case of someone with mental illness, substance abuse disorders, and developmental disabilities), an involuntary commitment may considered under Chapter 51 of the Wisconsin State Statutes if the person is not willing to seek treatment.

In the case of someone living with *dementia* however, with no accompanying mental illness, the State Supreme Court in its 2012 Helen E.F. decision ruled that Chapter 51 does not apply because dementia is not treatable in the same way that other illnesses are, and that a better option to consider is Chapter 55 of the Wisconsin State Statures which allows for Emergency Protective Placement and Service Provision.

#### A summary of both statutes follows:

#### Chapter 51

Provides legal procedures for voluntary and involuntary admission, treatment and rehabilitation of individuals (adults and minor children) afflicted with mental illness, developmental disability, or drug dependence.

#### Criteria:

- 1. The individual has a mental illness, developmental disability, or drug dependence.
- 2. The individual's illness/disability/ dependence is treatable.
- 3. The individual is dangerous to him/herself or others, due to the illness/disability/ dependence. Chapter 51 is used for more time-limited treatment.

#### Standards of Dangerousness Required for Involuntary Civil Commitment by the court.

- 1. Recent acts, attempts or threats of suicide or serious bodily harm to self.
- 2. Recent acts, attempts, or threats of serious bodily harm to others, or violent behavior which places others in reasonable fear of serious physical harm.
- 3. A pattern of recent acts or omissions which evidences impaired judgment causing the individual to be an inadvertent danger to self.
- 4. Mental illness causes the individual to be so gravely disabled that he/she is unable to satisfy life's basic needs for nourishment, medical care, shelter, or safety.
- 5. Individual's psychiatric treatment history, coupled with his/her present mental deterioration due to incompetent decision to refuse psychotropic medication, causes likelihood that the individual will lose ability to function independently in the community.

#### Methods of Initiating an Involuntary Civil Commitment Proceeding

- Law Enforcement Emergency Detention along with Treatment Director's Supplement (TDS)
- Treatment Director's Affidavit (TDA) Emergency Detention
- Three Party Petition for Examination
- Criminal case conversion

#### When Police Arrive:

When calling the police, you can request a Crisis Intervention Team Officer (CIT) via the non-emergency number of the local police department or 911. The police officer(s) will determine if the person meets the emergency detention requirements under Wisconsin Law. Your description of the persons threats or actions are important. The officer may act based upon observations by you or others. Give police your name, address and phone number for future contact. You may be needed as a witness for a commitment hearing in court at the mental health hospital. If witnesses do not appear, the case will be dismissed. If you are difficult to reach, call the Milwaukee County Corporation Counsel office as soon as possible at 414-278-5117.

# What happens to the person:

Police or ambulance takes the person to Milwaukee County Psychiatric Crisis Services (PCS). If there is a medical problem the person may be taken to a medical hospital first. Doctors decide if a person should be admitted to the hospital or released immediately. If the doctor believes that the person is a danger to themselves or others and a suitable candidate for treatment, they will complete a treatment directors supplement (TDS), which will keep the person in the hospital. The TDS will be completed within 24 hours of the emergency detention in Milwaukee County (weekends and holidays excluded).

#### What you can do:

If you have more information about the person, call PCS at 414-257-7260. PCS staff may listen to you information but may not be able to release information to you due to policy and laws governing information release.

#### At the Hospital:

If the person is admitted to the hospital involuntarily, and the TDS completed, there will be a court hearing (called a probable cause hearing) within 72 hours (weekends and holidays excluded). A lawyer will represent the person. A Milwaukee County Corporation Counsel attorney (414-278-5117) will handle the hearing and seek treatment for that person. The Court will decide if the person must stay at the hospital. If the person agrees to voluntarily accept treatment, there will be no need for court hearings. If not, there may be additional court hearing which may result in the person's mental health commitment. Being under a commitment, does not necessarily mean the person would be hospitalized for the entire commitment period, but treatment is provided in the least restrictive environment that meets that person's safety needs.

#### **Probable Cause Hearing**

- Court hearing must be held within 72 hours of individual's detention at a mental health facility (excluding weekends and holidays).
- Witnesses testify from personal observations about the allegations of dangerousness in the petition or ED, and doctor testifies about mental illness, disability, or dependence, and treatment.
- After the hearing, the judge or court commissioner determines if there is probable cause (reason) to believe the allegations, and cause to detain and treat the individual at a mental health facility.

# **Probable Cause Hearing:**

#### **Possible Outcomes**

- 1. Case is dismissed for lack of sufficient evidence that the individual is mentally ill or dangerous.
- 2. Settlement Agreement is approved by the court.
- 3. Case is converted to temporary guardianship and protective placement or services, if the individual does not have a treatable mental illness.
- 4. If Probable cause is found, a final hearing for commitment is scheduled within 14 days of detention.

#### **Three Party Petition – Chapter 51 Process**

Milwaukee County Office of Corporation Counsel handles Three-Party petitions to commit a person to involuntary treatment for either mental illness or substance abuse. Three people (ages 18 years and over) must come to the office on an appointment basis only. The office conducts a telephone interview to determine whether the situation meets the requirements of the law for commitment, which include:

- The subject must be believed to have a mental illness,
- be developmentally disabled,
- be suffering from alcoholism or be drug dependent

The condition must be believed to be treatable; and most importantly, the witnesses must have evidence that the person recently (in a two month window) engaged in behavior that created a substantial risk of harm to the person or others (violence or threats of violence, suicide attempts or threats or substantial patterns of self-neglect placing the subject at risk).

- This is about a two-week process. Milwaukee County Sheriff's Office does pick up after petition is approved by the court.

#### **Chapter 55 – Emergency Protective Placement**

Chapter 55 procedures apply to persons with long-term care needs. Chapter 55 provides legal procedures for emergency protective placements which are a means of intervening in an emergency situation if it is probable that an individual, as a result of an impairment as defined in Chapter 55, is incapable of providing for his or her own care or custody so as to create a substantial risk of physical harm to himself, herself or others if protective intervention is not immediately taken.

#### Criteria:

- 1. The individual has a permanent impairment such as severe and persistent mental illness, traumatic brain injury, degenerative brain disorder, developmental disability or other like incapacity.
- 2. The person's disability is permanent or likely to be permanent.
- 3. The person is so totally incapable of providing for his/her own care or custody as to create a substantial risk of serious harm to oneself or others. The harm can be proven by evidence of overt acts or acts of omission.

# **Standards Required for Involuntary Commitment under Chapter 55:**

- 1. The person has a primary need for residential care or custody.
- 2. The person is incompetent and requires a guardian under Chapter 54.
- 3. A pattern of recent acts or omissions which evidences impaired judgment causing the individual to be an inadvertent danger to self.

#### **Methods of Initiating an Emergency Protective Placement:**

Chapter 55 Statute provides that if from personal observation of or a reliable report made by a person who identifies him or herself to law enforcement, fire fighter, guardian or authorized representatives of a county department or agency, can detain an individual if above criteria is met.

#### **Probable Cause Hearing**

- Court hearing must be held within 72 hours of individual's detention at an EPP facility (excluding weekends and holidays).
- The Individual must have a guardian or a request for guardianship must accompany the petition for Emergency Protective Placement
- The Individual must be examined by a psychologist for competency and the report must accompany the petition.

#### **Probable Cause Hearing**

#### **Possible Outcomes:**

- 1. Case is dismissed for lack of sufficient evidence that the individual is appropriate for an Emergency Protective Placement.
- 2. Probable cause is found:
  - b. Temporary Guardianship and Protective placement order is initiated.
  - c. Final hearing is scheduled within 30 days of detention

#### The Least Restrictive Principle

Every aspect of Chapter 55 is controlled by the principle that people should get the services they need in the least restrictive setting most appropriate to meet their needs.

Chapter 55 covers protective services. A protective service may be any kind of care that can be provided to assist a person.

# **Emergency Protective Placement**

Chapter 55 provides a way to intervene in an emergency situation if it appears probable that:

- The individual will suffer irreparable injury or death or
- Will present a substantial risk of serious physical harm to others.

#### **EMTALA – Emergency Medical Treatment and Labor Act**

The Emergency Medical Treatment and Labor Act is a statute which governs when and how a patient must be:

- (1) examined and offered treatment or
- (2) transferred from one hospital to another when he is in an unstable medical condition.

It's also sometimes also referred to as the "COBRA" law.

EMTALA applies only to "participating hospitals" under Medicare — i.e., to hospitals which have entered into "provider agreements" under which they will accept payment from the Department of Health and Human Services, Centers for Medicare and Medicaid Services (CMS) under the Medicare program for services provided to beneficiaries of that program.

In practical terms, this means that it applies to virtually all hospitals in the U.S., with the exception of the Shriners' Hospital for Crippled Children and many military (VA) hospitals. Its provisions apply to all patients, and not just to Medicare patients. (See question 15.)

The avowed purpose of the statute is to prevent hospitals from rejecting patients, refusing to treat them, or transferring them to "charity hospitals" or "county hospitals" because they are unable to pay or are covered under the Medicare or Medicaid programs.

EMTALA is primarily but not exclusively a non-discrimination statute. One would cover most of its purpose and effect by characterizing it as providing that <u>no patient who presents with an emergency medical condition and who is unable to pay may be treated differently than patients who are covered by health insurance.</u>

# HIPPA and Law Enforcement Information from: <a href="https://www.hhs.gov/hipaa/for-professionals/faq">https://www.hhs.gov/hipaa/for-professionals/faq</a>

The Privacy Rule is balanced to protect an individual's privacy while allowing important law enforcement functions to continue. The Rule permits <u>covered entities</u> to disclose protected health information (PHI) to law enforcement officials, without the individual's written authorization, under specific circumstances summarized below. For a complete understanding of the conditions and requirements for these disclosures, please review the exact regulatory text at the citations provided. Disclosures for law enforcement purposes are permitted as follows:

- To comply with a court order or court-ordered warrant, a subpoena or summons issued by a judicial officer, or a grand jury subpoena. The Rule recognizes that the legal process in obtaining a court order and the secrecy of the grand jury process provides protections for the individual's private information (45 CFR 164.512(f)(1)(ii)(A)-(B)).
- To respond to an administrative request, such as an administrative subpoena or investigative demand or other written request from a law enforcement official. Because an administrative request may be made without judicial involvement, the Rule requires all administrative requests to include or be accompanied by a written statement that the information requested is relevant and material, specific and limited in scope, and de-identified information cannot be used (45 CFR 164.512(f)(1)(ii)(C)).
- To respond to a request for PHI for purposes of identifying or locating a suspect, fugitive, material witness or missing person; but the covered entity must limit disclosures of PHI to name and address, date and place of birth, social security number, ABO blood type and rh factor, type of injury, date and time of treatment, date and time of death, and a description of distinguishing physical characteristics. Other information related to the individual's DNA, dental records, body fluid or tissue typing, samples, or analysis cannot be disclosed under this provision, but may be disclosed in response to a court order, warrant, or written administrative request (45 CFR 164.512(f)(2)).

#### This same limited information may be reported to law enforcement:

- About a suspected perpetrator of a crime when the report is made by the victim who is a member of the covered entity's workforce (45 CFR 164.502(j)(2));
- To identify or apprehend an individual who has admitted participation in a violent crime that the covered entity reasonably believes may have caused serious physical harm to a victim, provided that the admission was not made in the course of or based on the individual's request for therapy, counseling, or treatment related to the propensity to commit this type of violent act (45 CFR 164.512(j)(1)(ii)(A), (j)(2)-(3)).
- To respond to a request for PHI about a victim of a crime, and the victim agrees. If, because of an emergency or the person's incapacity, the individual cannot agree, the covered entity may disclose the PHI if law enforcement officials represent that the PHI is not intended to be used against the victim, is needed to determine whether another person broke the law, the investigation would be materially and adversely affected by waiting until the victim could agree, and the covered entity believes in its professional judgment that doing so is in the best interests of the individual whose information is requested (45 CFR 164.512(f)(3)).

Where child abuse victims or adult victims of abuse, neglect or domestic violence are concerned, other provisions of the Rule apply:

- Child abuse or neglect may be reported to any law enforcement official authorized by law to receive such reports and the agreement of the individual is not required (45 CFR 164.512(b)(1)(ii)).
- Adult abuse, neglect, or domestic violence may be reported to a law enforcement official authorized by law to receive such reports (45 CFR 164.512(c)):
  - If the individual agrees;
  - If the report is required by law; or
  - If expressly authorized by law, and based on the exercise of professional judgment, the report is necessary to prevent serious harm to the individual or others, or in certain other emergency situations (see 45 CFR 164.512(c)(1)(iii)(B)).
  - Notice to the individual of the report may be required (see 45 CFR 164.512(c)(2)).
- To report PHI to law enforcement when required by law to do so (45 CFR 164.512(f)(1)(i)). For example, state laws commonly require health care providers to report incidents of gunshot or stab wounds, or other violent injuries; and the Rule permits disclosures of PHI as necessary to comply with these laws.
- To alert law enforcement to the death of the individual, when there is a suspicion that death resulted from criminal conduct (45 CFR 164.512(f)(4)).
  - Information about a decedent may also be shared with medical examiners or coroners to assist them in identifying the decedent, determining the cause of death, or to carry out their other authorized duties (45 CFR 164.512(g)(1)).
- To report PHI that the covered entity in good faith believes to be evidence of a crime that occurred on the covered entity's premises (45 CFR 164.512(f)(5)).
- When responding to an off-site medical emergency, as necessary to alert law enforcement about criminal activity, specifically, the commission and nature of the crime, the location of the crime or any victims, and the identity, description, and location of the perpetrator of the crime (45 CFR 164.512(f)(6)). This provision does not apply if the covered health care provider believes that the individual in need of the emergency medical care is the victim of abuse, neglect or domestic violence; see above Adult abuse, neglect, or domestic violence for when reports to law enforcement are allowed under 45 CFR 164.512(c).
- When consistent with applicable law and ethical standards:
  - o To a law enforcement official reasonably able to prevent or lessen a serious and imminent threat to the health or safety of an individual or the public (45 CFR 164.512(j)(1)(i)); or
  - To identify or apprehend an individual who appears to have escaped from lawful custody (45 CFR 164.512(j)(1)(ii)(B)).
- For certain other specialized governmental law enforcement purposes, such as:
  - To federal officials authorized to conduct intelligence, counter-intelligence, and other national security activities under the National Security Act (45 CFR 164.512(k)(2)) or to provide protective services to the President and others and conduct related investigations (45 CFR 164.512(k)(3));

o **To respond to a request for PHI by a correctional institution or a law enforcement official having lawful custody** of an inmate or others if they represent such PHI is needed to provide health care to the individual; for the health and safety of the individual, other inmates, officers or employees of or others at a correctional institution or responsible for the transporting or transferring inmates; or for the administration and maintenance of the safety, security, and good order of the correctional facility, including law enforcement on the premises of the facility (45 CFR 164.512(k)(5)).

Except when required by law, the disclosures to law enforcement summarized above are subject to a minimum necessary determination by the covered entity (45 CFR 164.502(b), 164.514(d)). When reasonable to do so, the covered entity may rely upon the representations of the law enforcement official (as a public officer) as to what information is the minimum necessary for their lawful purpose (45 CFR 164.514(d)(3)(iii)(A)). Moreover, if the law enforcement official making the request for information is not known to the covered entity, the covered entity must verify the identity and authority of such person prior to disclosing the information (45 CFR 164.514(h)).

Mandated Child Abuse and Neglect Reporting from: https://dcf.wisconsin.gov/cps/mandatedreporters Wisconsin law (48.981(2)) requires that any mandated reporter who has reasonable cause to suspect that a child seen by the person in the course of professional duties has been abused or neglected, or who has reason to believe that a child seen by the person in the course of professional duties has been threatened with abuse or neglect and that abuse or neglect of the child will occur, make a report to county CPS or law enforcement.

In addition, Wisconsin law (175.32) requires that any mandated reporter who believes in good faith, based on a threat made by an individual seen in the course of professional duties regarding violence in or targeted at a school, that there is a serious and imminent threat to the health or safety of a student or school employee or the public, make a report to law enforcement.

The professionals named as mandated reporters in the Wisconsin Statutes 48.981 (2) are as follows:

- Physicians
- Coroners
- Medical examiners
- Nurses
- Dentists
- Chiropractors
- Optometrists
- Acupuncturists
- A medical or mental health professional not otherwise specified in this list
- Social workers
- Marriage & family therapists
- Professional counselors
- Public assistance workers, including a financial and employment planner, as defined in s49.141(1) (d),
   Statutes
- School teachers
- School administrators
- School counselors
- School employees not otherwise specified in this list
- Mediators under s.<u>767.11</u>, Statutes

- Child-care workers in a child care center, group home, or residential care center for children and youth
- Child care providers
- Alcohol or other drug abuse counselors
- Members of the treatment staff employed by or working under contract with a county department under s. 46.23, 51.42, or 51.437, Statutes, or a residential care center for children and youth
- Physical therapists
- Physical therapist assistants
- Occupational therapists
- Dieticians
- Speech-language pathologists
- Audiologists
- Emergency medical technicians
- First responders
- Police or law enforcement officers
- Court-appointed special advocates (CASA) (except as provided in subs. (2m) and (2r))
- Clergy (specific requirements and exceptions found under s.48.981(2)(bm)1-3)
- Juvenile correctional officers

In addition, the professionals named as mandated reporters in the <u>Governor's Executive Order #54</u> are as follows:

- University of Wisconsin System (UWS) Professors
- UWS Administrators
- UWS Coaches
- All other UWS Employees

Reports of suspected child abuse and neglect can be made to the <u>county</u> where the child resides or to the law enforcement of where the possible abuse and/or neglect occurred. Reports of suspected school violence must be made to law enforcement.

- Persons making reports in good faith are immune from criminal or civil liability.
- A person who is mandated to report suspected child abuse or neglect will be informed by the county
  what action, if any, was taken to protect the health, safety, and welfare of the child who is the
  subject of the report.
- Penalty: Persons required to report, who intentionally fail to report suspected child abuse or neglect or threats of school violence may be <u>fined up to \$1,000 or imprisoned up to 6 months or both</u>.

# U.S. Department of Justice

FACT SHEET: What Law Enforcement Officers "Need to Know" about the Federal Medical Records Privacy Regulation and Access to "Protected Health Information"

- Since April 14, 2003, a federal regulation gives federal privacy protections to medical records (45 Code of Federal Regulations Parts 160 & 164).
- The regulation places legal obligations on doctors, hospitals, pharmacies, insurance companies, etc., governing their ability to disclose medical information about a suspect or victim and may, *in some situations*, prevent them from giving such information.
- This <u>FACT SHEET</u> will help law enforcement officers understand how to obtain personal medical evidence needed for investigations, within the bounds of federal law.

Health Insurance Portability and Accountability Act of 1996 (HIPAA): Standards for Confidentiality of Individually Identifiable Health Information (HIPAA Privacy Rule)

- HIPAA's "Standards for Confidentiality of Individually Identifiable Health Information"
  governs how and when a "Covered Entity" can use or disclose "individually identifiable
  health (medical) information (in whatever form) concerning an individual person (in HIPAA
  terminology: "protected health information").
- There are three types of *Covered Entities* under HIPAA: (1) <u>health plans</u>: group and individual health insurance, HMOs, Medicare, Medicaid and other government health plans; (2) <u>health care clearinghouses</u>: billing services and providers; (3) <u>health care providers</u>: doctors, nurses, paramedics and other emergency services personnel; hospitals and clinics; pharmacies (see 45 CFR 160.103). A fourth type of covered entity included Medicare prescription drug discount card sponsors.
- **Protected health information** is "individually identifiable health information" which is transmitted by electronic media, or maintained in any electronic medium (defined at 45 CFR 162.103), or transmitted or maintained in any other form or medium (essentially all health records identifiable by a patient name or other personal identifier such as a Social Security Number is **protected health information!**).
- As a general rule, *Covered Entities* may not use or disclose *protected health information* unless permitted by a provision of the rules, such as the
  - patient provides written authorization (permission) for the disclosure, or
  - disclosure is for a *health oversight* purpose, or
  - disclosure is for a certain law enforcement purpose (see back of this Fact Sheet), or
  - disclosure is otherwise required by law, e.g., statute, subpoena, court order.
- The behavior of government agencies that are <u>not</u> covered entities (e.g., law enforcement) is <u>not</u> regulated by the HIPAA Privacy Rule, but when *law enforcement agencies* seek protected health information from covered entities, the rules will dictate how the covered entities respond to law enforcement requests for *protected health information*.

The HIPAA Privacy Rule provides "<u>law enforcement exceptions</u>" to the requirement that patients authorize a Covered Entity's disclosure of their protected health information. So, if a Covered Entity or a person speaking on behalf of a Covered Entity, says: "Sorry, officer, I can't give you that information because of the HIPAA privacy regulations..." or "the patient didn't authorize this disclosure..."

(over)

You can respond with one of the following responses, IF it applies... "Yes, [Covered Entity], you can give me the information I need because [one of the following law enforcement exceptions applies] ..."

- 1. Required by law [45 CFR 164.512(f)(1)(i)] e.g., "the laws of this State require reporting of [certain types of wounds or other physical injuries...] to law enforcement agencies..."
- 2. Court order, or warrant, subpoena or summons issued by a judicial officer [45 CFR 164.512(f)(1)(ii)(A)] "I am serving a court-ordered subpoena on you, so can (and must) produce the medical records I am seeking."
- 3. Grand jury subpoena [45 CFR 164.512(f)(1)(ii)(B)] "I am serving a grand jury subpoena on you, so you can (and must) produce the medical records that I seek."
- 4. Administrative subpoena or request, but only if 3 specific requirements are met [45 CFR 164.512(f)(1)(ii)(C)] "because I am serving an administrative subpoena on you, and I certify that the subpoena meets the three-part test... (1) the information sought is material to a legitimate law enforcement inquiry); (2) the request is specific and limited in scope to the purpose for which it is being sought; and (3) de-identified information could not reasonably be used (i.e., without SSN or name, the information would be useless as evidence).
- 5. <u>Locate or identify</u> [45 CFR 164.512(f)(2)"I am trying to locate OR identify a suspect... fugitive...material witness...OR a missing person." This exception will permit access to 8 types individually identifiable information (but excludes DNA, dental records, body fluid, or tissue, which would require a subpoena).
- 6. <u>Information about a victim of a crime [45 CFR 164.512(f)(3) "I need this information about this person, who is or I suspect is a victim of a crime...or to determine if someone else committed a crime...that cannot be delayed until the victim approves the disclosure..."</u>
- 7. <u>Crime on premises</u> [45 CFR 164.512(f)(5)] "the [covered entity] believes that the information is evidence of a crime that occurred on the premises" (e.g. a nursing home, hospital, etc.)
- 8. Reporting crime in emergencies [45 CFR 164.512(f)(6)] "you are an emergency health care worker who responded to a medical emergency outside the hospital (etc.) and you can tell law enforcement about the commission and nature of the crime; location of the crime and victims; the identity, description or location of the perpetrator..."
- 9. <u>Victims of abuse, neglect, domestic violence</u> [45 CFR 164.512(c)] This exception is limited to four specific scenarios; if possible, get a subpoena or the individual's agreement to use his/her medical information instead of relying on this exception.
- 10. Coroners [45 CFR 164.512(g)(1)] "because the coroner or medical examiner needs the information to determine the cause of death or perform his other duties."
- 11. To avert a serious threat to health/safety [45 CFR 164.512(j) "the disclosure is necessary to avert a serious and imminent threat to a person's safety or the public...; OR to identify or apprehend an individual ... because that individual admitted participating in a violent crime that may have caused serious physical harm to the victim"; OR "to identify or apprehend someone who escaped from a correctional institution or from lawful custody."
- 12. Other important miscellaneous exceptions: national security and intelligence; protective services for the President and others; jails, prisons, law enforcement custody to safeguard the person/s in custody or corrections employees who are in proximity of the person/s in custody.

Remember to show your badge, that you need to satisfy only ONE of the <u>law enforcement exceptions</u>, AND that you also must familiarize yourself with the requirements of your state's medical records privacy laws. To stop a Covered Entity from disclosing to patients that you have their medical information, (1) make an oral request that the entity not make a disclosure to the patient and (2) follow up with a written request, on official letterhead, within 30 days.
