- Integration is a part of DHHS No Wrong Door model, providing easy access to quality care for children, youth & families
- Brings together children's disability services, youth justice and children's mental health & Wraparound
- Centralized intake & screening process for children & youth for mental health and disability services
- The goal is to divert youth from the justice system and set them up for success in their homes and communities
- Assesses children and youth earlier when they are in the youth justice system
 - Multi Disciplinary Staffing & Central Staffing
 - Intake & Functional Assessments for justice involved youth

DHHS Children's Integration

- Increased enrollment in Comprehensive Community Services (CCS) – dual enrollment with CLTS
- Number of children in CLTS has increased over 40% in 2021
- Collaboration with Aging & Disability Services to support the transition of youth into adult services
- Increase awareness of DHHS & intentional efforts to bring resources to the neighborhoods & people

Milwaukee County believes that it is necessary and possible to establish a new paradigm of youth justice that assures our youth receive proper care under conditions that promote growth and affirms, rather than destroys, the social contract between youth and society.


We know that Lincoln Hills & Copper Lake are not the answer. If <u>three kids</u> get sent to LHS/CLS, that's over \$1.2M out of our budget that could have served 100 youth in Milwaukee County. The cost to send a youth to Lincoln Hills is \$429,000 per youth per year with a daily rate of \$1,178. Amount of money spent on youth programs pales in comparison to youth corrections.

Shift the paradigm in youth justice to address the unique needs of youth identified in growth focused case plan & reduce risk.

The safest communities are ones in which everyone's needs are met.

New Paradigm in Youth Justice


Youth Justice System Continuum of Care

Data on Justice Involved Youth

- Estimated that 60% of justice involved youth have undiagnosed mental health issue
- Greatest needs identified are around substance use and mental health resources
- There were over 215 justice involved youth served in Wraparound services (2021)
- Over 80% of justice involved youth with mental health diagnosis (2021)
- Over 89% of justice involved youth had IEP/special education interventions (2021)

Continued expansion of Comprehensive Community Services & Children's Long-Term Support

Launched initiative to increase screening for disabilities in youth who are justice system involved


Over 150 Youth/Mentor Connections Created via Credible Messengers

Over 250 young people from our youth justice, disabilities, and behavioral health programs enrolled in Collaborative Employment Programming in 2021 & 2022

Increased coordination and expansion of service provider network; capacity building for providers

Partnership between MKE County Behavioral Health Services and City of MKE Office of Violence Prevention where more than 10,000 gun locks were distributed in 2021
