Personnel Changes

 To combat severe staffing shortages in the Jail, a \$6.06 per hour pay increase for Correctional Captain, Correctional Officer Lieutenant, Correctional Officer Sergeant, and Correctional Officers is requested.

New Positions

- Requested 33.0 FTE Deputy Sheriff positions to combat overtime and staff shortages in the Courts, Patrol and Investigations. (Net increase 27.0 FTE due to 6.0 FTE at County Grounds eliminated)
 - 18.0 FTE Courts
 - 10.0 FTE Patrol
 - 5.0 FTE Investigations



New Positions (Continued)

- Requested 5.0 FTE Deputy Sheriff Sergeant positions to bridge the supervisory gap that exists at MCSO.
 - 3.0 FTE Patrol
 - 2.0 FTE Courts
- Requested \$364,977 for Hourly Bailiff positions to start a pilot program to reduce overtime by employing certified law enforcement officers as bailiffs at the Courthouse Complex
- Requested additional \$286,894 for Hourly Background Investigator positions to alleviate 3-4 month lag in background compilations so when offers are made candidates are still available for hire.





Other Personnel Changes

- Requested \$366,682 for pay compression resulting from the Milwaukee Deputy Sheriff Association (MDSA) settling their most recent contract.
- Requested an additional \$169,148 for the Collateral Agreement with the MDSA concerning changes to the §3.03 call in pay and §3.04 standby pay

Overtime

 An additional \$1,571,461 in overtime requested mainly in the Jail and the Courts Program Areas.





Other Changes

- Increase of \$767,463 in cross charges for 2024 due to the change in cross charge policies. MCSO must cover these increases from other agencies in our operating budget, which puts personnel and programs within the MCSO's budget at jeopardy of being eliminated.
- Revenue reduction from sunsetting the Froedtert Memorial Lutheran Hospital security (\$550,474) and the Freeway Service Team (\$240,000)
- General Transportation Aids (GTA) Revenue request of \$2,936,092 includes a \$170,000 increase and Traffic Mitigation contracts of \$500,000 includes a \$100,000 increase.
